

tration was engaged in a plot to falsify information and cover up those lies to justify its illegal invasion of Iraq." Hinchey has led the effort in Congress to have Special Counsel Patrick Fitzgerald expand his investigation. He says the key question is why the leak happened in the first place. He says the answer is tied to false claims of weapons of mass destruction. "This administration is the most corrupt and incompetent administration in U.S. history," Hinchey concluded. "The American people deserve to have the cloud hanging over Vice President Cheney and other administration officials lifted once and for all so we can find out the truth."

On Tuesday, after nine weeks of deliberation, a jury convicted Vice President Dick Cheney's former chief of staff I. Lewis "Scooter" Libby of obstructing justice, making false statements and lying about the outing of Valerie Wilson as a CIA agent. Congressman Maurice Hinchey (D-NY) has released the following statement on the verdicts: "Justice was served today when Scooter Libby was found guilty, and now other administration officials, starting with Vice President Cheney, must be held accountable for their role in this case. The truth behind why Scooter Libby lied must now be revealed. This is the first judicial evidence that the Bush adminis-
